Want to get a jump-start on your college education? You can enroll in college courses while you're still in high school through the post-secondary enrollment options program, created by section 3365.02 of the Ohio Revised Code.

### Admission Process

Don't miss your chance to participate in a program that allows you to explore your interests, prepare for college and even meet new friends. This selective program enrolls a maximum of 50 students from participating schools. Admission is competitive, but the application process is easy. Simply complete this free application and give it to your high school guidance counselor. Your counselor will then approve your participation, review your course selection, attach your official transcript and send everything to our office.

While ACT/SAT scores are not required for juniors and seniors, you may include this information on your transcript if you have taken the test.

### Admission Guidelines

In order to be eligible for the High School Scholars Program, you should have a GPA above the stated minimum (3.25 for seniors; 3.5 for juniors; 3.9 for sophomores; 4.0 for freshmen) and have completed a certain number of college preparatory courses (13 for seniors; 9 for juniors; 9 for sophomores; 9 for freshmen). You must also have your high school's approval to participate. Make sure to submit your application before the deadline — May 1 for the fall semester and Nov. 1 for the spring semester.

If you are a freshman or sophomore, you must also submit test scores (minimum 29 ACT or 1300 SAT critical reading and math); participate in an interview; submit two letters of recommendation (one from your principal and one from a teacher); and complete an essay.

Admission to the High School Scholars Program does not guarantee admission to the University of Dayton as an undergraduate. We encourage you to apply for admission as a full-time undergrad during your senior year.

### Registration Process

After you are accepted as a High School Scholar, you will meet with the program coordinator to register for classes. To prepare you for course work and help you find your way around campus, you'll participate in a required on-campus orientation before classes begin.

As a High School Scholar, you'll get a taste of the real college experience as you take up to two courses per semester alongside current undergraduates. Normally, you will be able to register for 100- and 200-level courses — entry-level, general education courses that challenge you and offer a solid foundation for your education.

Anticipated classes for the fall 2014 and spring 2015 terms are included in this brochure, and others will be considered upon request. Courses are offered on a space-available basis, so we cannot guarantee that your requested courses will be available.

To continue in this program, you must earn a grade of C+ or better in your chosen course(s).

### Enrollment Options

To meet your goals and interests, two types of enrollment are available.

Option A allows you to enroll for college credit only. You'll pay tuition and laboratory fees (if applicable) and purchase necessary books and supplies. Tuition costs will be charged at 40 percent of the regular rate.

Option B allows you to enroll for both high school credit and college credit. With this option, tuition, laboratory fees and books are covered in full through state and University funding.
