You'll work closely with your academic adviser to develop a degree plan that ensures you graduate on time. That's just one reason our graduates leave with average student loan debt below the national average and 95 percent of our students are employed, in graduate school or in a full-time volunteer program within six months of graduation.

You have received the textbook scholarship. We will provide **up to \$4,000 over four years toward your textbook expenses** (up to \$500 per semester).

The average UD graduate leaves with less than \$19,000 in student loans, which is below the national average for all four-year private institutions.

Eighty-four percent of UD students begin to repay their student loans within three years of leaving school, compared to 46% nationally. Ninety-five percent of UD students are employed or enrolled in graduate school within six months of graduation.
