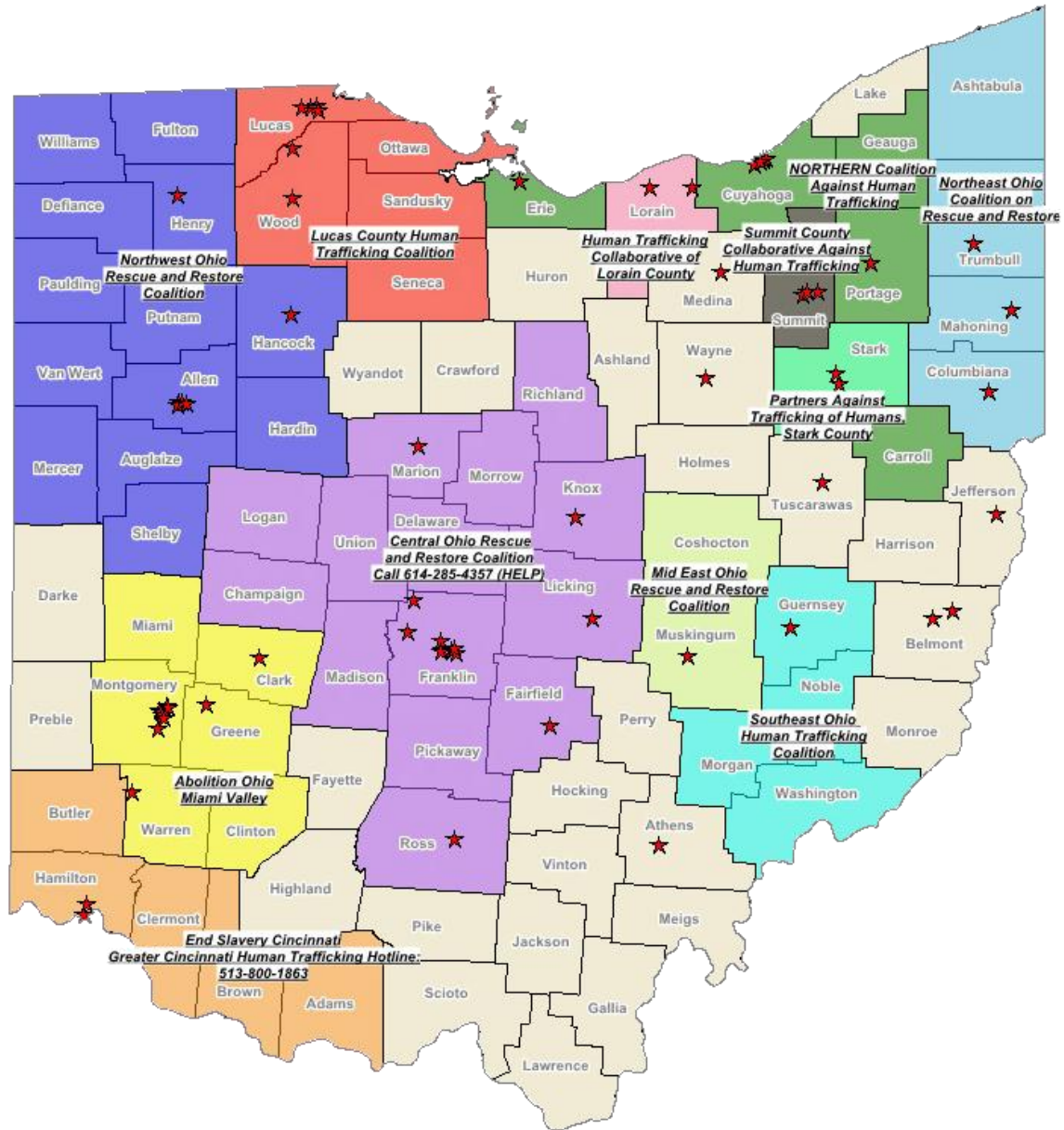
Map of Counties Covered by Abolition Ohio

Human Trafficking Federal Definition (Trafficking Victims Protection Act of 2000)

- (A) sex trafficking in which a commercial sex act is induced by force, fraud, or coercion, or in which the person induced to perform such act has not attained 18 years of age; or
- (B) the recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of force, fraud, or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery.

Plain Language Definition

Human Trafficking is the Modern Day Slave Trade.

Human beings—mostly women and children are forced, tricked, or threatened into situations where they work for little or no pay and often are unable to leave. Their labor and their bodies are exploited for another’s profit. They are subjected to horrible physical, psychological, and spiritual abuse that leaves them scarred for life—if they survive the ordeal.

Scope and Scale of Human Trafficking

- Over Twenty-seven million slaves exist in the world today
- Case documented in over **160** countries and all **50** US States
- **Two hundred thousand** people are currently enslaved in the US
- Up to **17,500** new victims are trafficked across US borders each year
- **\$32 billion+** in revenue each year
- **80%** of Victims are **Female**—**50%** are **Children**
- **100,000 CHILDREN** in US are exploited for commercial sex (prostitution)
- **300,000 CHILDREN** in US are vulnerable to sexual exploitation
- The average age of entry into prostitution in US is **12-14 YEARS OLD**
- The average life expectancy of a prostitute in the US is **7 YEARS**
- Women, girls, and boys can be sex trafficked
- Toledo: **#1** per capita in recruiting most traffickers and most underage girls into prostitution
- Toledo: **#4** city in arrests and investigations related to child sex trafficking
- Over 100 cases investigated in Ohio since 2003
- **783** foreign persons trafficked into Ohio’s labor and sex trade within past year
- **1,078** American-born Ohio youth trafficked into sex trade within past year
- Nearly **3,000** American-born Ohio youth at risk for sex trafficking

Red Flags: Indicators of Potential Trafficking (Source: www.polarisproject.org)

The Individual(s) in Question...

- Is not free to leave or come and go as he/she wishes
- Is under 18 years of age and is providing commercial sex acts
- Is in the commercial sex industry and has a pimp/manager
- Is unpaid, paid very little, or paid only through tips
- Works excessively long and/or unusual hours
- Is not allowed breaks or suffers under unusual restrictions at work
- Owes a large and/or increasing debt and is unable to pay it off
- Was recruited through false promises concerning the nature and conditions of his/her work
- Is living or working in a location with high security measures (e.g. opaque or boarded-up windows, bars on windows, barbed wire, security cameras, etc.)
- Exhibits unusually fearful, anxious, depressed, submissive, tense, or nervous/paranoid behavior
- Reacts with unusually fearful or anxious behavior at any reference to “law enforcement”
- Avoids eye contact
- Exhibits a flat affect
- Presents with unexplained injuries or signs of prolonged/untreated illness or disease
- Appears malnourished
- Shows signs of physical and/or sexual abuse, physical restraint, confinement, or torture
- Has few or no personal possessions
- Is not in control of his/her own money, and/or has no financial records, or bank account
- Is not in control of his/her own identification documents (e.g. ID, passport, or visa)
- Is not allowed or able to speak for him/herself (e.g., a third party may insist on being present and/or interpreting)
- Has an attorney that he/she doesn’t seem to know or to have agreed to receive representation services from
- Has been “branded” by a trafficker (e.g. a tattoo of the trafficker’s name)
- Claims to be “just visiting” and is unable to clarify where he/she is staying or to provide an address
- Exhibits a lack of knowledge of whereabouts and/or does not know what city he/she is in
- Exhibits a loss of sense of time
- Has numerous inconsistencies in his/her story

Human Trafficking--Key questions to ask

Potential Sex and Labor Trafficking Victims

- What type of work do you do?
- Are you being paid?
- Can you leave your job if you want to?
- Can you come and go as you please?
- Have you or your family been threatened?
- What are your working and living conditions like?
- Where do you sleep and eat?
- Do you have to ask permission to eat/sleep/go to bathroom?
- Are there locks on your doors/windows so you cannot get out?
- Has your identification or documentation been taken from you?

Additional questions for Potential Sex Trafficking Victims (adapted from St. Louis Human Trafficking Manual)

- Where did you sleep last night?
- How much older is your boyfriend?
- It seems like you're a little scared of your boyfriend. Would you like to talk about that with me?
- It's tough to be out there on your own, how are you surviving on the streets?
- Has anyone ever asked you to, or made you feel like you had to have sex in exchange for money, shelter, clothes or food?

Please Note:

- It is always recommended to use their terminology in using pronouns, titles (boyfriend, partner, etc.), and other potentially "loaded" terms.
- If a victim wishes to proceed with legal proceedings, she will have to repeat all of this information to law enforcement. If you identify a potential victim who may wish to go forward with legal proceedings, it is recommended to stop asking for further information/details and wait for the formalized interview by law enforcement.

Out of the Shadows: A Tool for the Identification of Victims of Human Trafficking

The landmark Trafficking Victims Protection Act made trafficking in persons a federal crime in 2000, but the greatest obstacle to rescuing victims of human trafficking is identifying them. To make identifying these people easier—and subsequently, getting them the services and support they need while also generating evidence against their traffickers—Vera created a screening tool to be used by victim service providers and law enforcement when faced with someone who may be a victim of human trafficking. The tool, a 30-topic questionnaire that was tested by service providers and validated by Vera researchers, is the result of a two-year study funded by the National Institute of Justice.

Health Effects of Human Trafficking

Victims of human trafficking can face significant problems. Often physically and sexually abused, they have distinctive medical and psychological needs that must be addressed. The destructive effects can create a number of long-term health problems including:

Physical Effects	Psychological Effects
<ul style="list-style-type: none">· Sleeping and eating disorders· Sexually transmitted diseases, HIV/AIDS, pelvic pain, rectal trauma and urinary difficulties from working in the sex industry· Chronic back, hearing, cardiovascular or respiratory problems from endless days toiling in dangerous agriculture, sweatshop or construction conditions· Sexual dysfunction· Muscle tension· Untreated illnesses	<ul style="list-style-type: none">· Fear and anxiety· Depression, mood changes· Guilt and shame· Cultural shock from finding themselves in a strange country· Posttraumatic Stress Disorder· Dissociative Identity Disorder· Traumatic Bonding with the trafficker· High risk behaviors (i.e., drug and alcohol abuse)· Impaired judgment· Emotional exhaustion· Feelings of being mentally broken· Spiritual questions· Suicidal Ideation· Difficulty establishing/maintaining healthy relationships

Specific Health Indicators

The following indicators may present in the context of a physical exam or similar health assessment or treatment

- Malnourishment or generally poor health
- Signs of physical abuse – in particular, unexplained injuries or signs of prolonged abuse
- Evidence of a prolonged infection that could easily be treated through a routine physical/check up
- Addiction to drugs and/or alcohol
- Individual has no idea when his/her last medical exam was
- Lack of healthcare insurance – i.e. paying with cash

Human Trafficking Prevention & Intervention Protocol

If you suspect human trafficking is taking place:

- Look for the Red Flags
- Reach out to the victim and offer support
- Many victims will deny anything is happening
- Inform your supervisor (if mandated reporter)
- Call local law enforcement (Call 911 if someone is in immediate danger)
- For child—Report to Children’s Services
- Call the National Hotline: **888-3737-888**
