**Eligibility Requirements:** Require better than a 3.0 GPA as well as an 18-20 hour per week work commitment. Students must be an Economics, Finance, Marketing or Management Information major.

**Completion Requirements:** Requirements for successful completion is to work regularly scheduled hours, complete project assignments in a timely manner and to complete assignments correctly. Students must write well and be able to complete draft reports. Interns must be able to multi-task and prioritize assignments.

**Can non-majors do internships in this program?** No

**Additional Information** Interns are expected to be computer literate and have the ability to pick up new programs. Students should write well and expect to handle a variety of duties as an intern. Students, regardless of their major, may be expected to view focus groups and write draft reports, analyze data and make tables and cross-tabulations using SPSS, and perform secondary research for projects. Interns are seen as part of the management team and work on projects in various capacities. Interns are expected to participate actively in staff meetings and project meetings. Interns will be interacting with clients, as well as respondents contacted for projects, and are expected to act professionally at all times.

**On average, how many students participate in this program each year?** 3 to 5

**Where are some of the places these students are interning?** All interns work at the Business Research Group, a profit center for the School of Business Administration.

**Other Information** Working as an intern for BRG is more like working in a small business. As a profit center, BRG is concerned with productivity, cost on projects, and outcomes. ### Credit/Non-Credit Credit

**Eligibility Requirements** Students must have a 3 GPA on a 4-point scale in Communication, and have successfully completed the department's four core classes: communication modules, CMM 201, 202 & 330. Students also must define specific educational objectives for an internship, and complete an Internship Learning Agreement, among a few other things. Students must meet with the Internship Coordinator to finalize educational objectives.

**Completion Requirements** Students must maintain a record of their learning and work, submit regular reports to the Internship Coordinator, write a reflective paper assessing their learning outcomes, and submit a professional portfolio with work samples at the end of the internship.

**Can non-majors do internships in this program?** No

**Additional Information** Academic credit for internships is limited to 3 credit hours per internship, with a total of 6 credits possible by doing two internships at different jobs with different responsibilities. Internships must relate to the major, and work must be supervised by a professional in the communication field. Internships should be meaningful, educational experiences for students. Students must be enrolled in the course concurrent with the internship, registration cannot be deferred. Students may get academic credit for internships that are paid or unpaid. Companies are encouraged to offer students compensation - a stipend, minimum wage, or a reasonable salary.

Student must have at least 12 semester hours of upper-divisional hours in Criminal Justice Studies and have at least a 2.50 total cumulative average while attending UD. Resume must be current, and student may not be presently employed in law enforcement, the courts or corrections, and not had previous full-time employment in criminal justice.

**Eligibility Requirements** English major or minor or non-major pursuing the Writing Certificate. 3.0 GPA or better in English; 2.5 GPA overall or better; completion of an advanced writing course with a B or better; junior or senior class standing. Submit resume, writing samples, and application form to Internship Coordinator.

**Completion Requirements** Student must meet with Internship Coordinator three times during the semester (before internship begins, midterm week, finals week). By finals week, student must provide Internship Coordinator with the following. Credit for the class will not be awarded if all of the following are not received by the designated dates: \* Internship Journal: A collection of weekly journal entries of what the student did during the placement. Journal entries should address what the intern is learning on the job as well as how the job experiences and coworkers are affecting the intern, positively or negatively. \* Artifact File: A collection of samples to demonstrate what the intern worked on during the placement; photocopies are acceptable. \* Student Midterm Evaluation: Student will answer a brief list of questions at the midpoint of the internship and meet with supervisor to discuss work to date. \* Supervisor's Midterm and Final Evaluations: Evaluations from the placement supervisor will serve as supporting documents to confirm what the student presents in the internship report and artifact file. These evaluations can assist the English Department in measuring the value of the internship experience. \* An Essay of Assessment: Handed in at the end of the internship, this essay should discuss how well the experience met the goals of the internship, the student's strengths and weaknesses, etc.

**Eligibility Requirements** Semester of Service is a unique opportunity for UD sophomores through first semester seniors to take a semester away from classes and serve full-time in non-profit centers for inner-city children and teens, individuals who are homeless, and neighborhoods undergoing revitalization. Students gain new skills, insight into social justice issues, and earn a stipend, all while continuing their UD education.

**Completion Requirements** In UDI393, the 3 credit mini course which accompanies the SoS experience, students submit weekly journal entries, participate in class discussions and reflections, and write a final paper based on their experiences. The opportunity to earn additional independent study credits through a department of your choice, also exists.

**Success Stories** "My first few weeks of service were a real eye opener for me. The kids in this community have a very different childhood from my own. I realized early on that I can not fix their situations. I can, however, listen to them, be a positive role model and provide a safe place for them to be after school, I am a mentor. I have a definite place in the East End community and that has helped me get a lot out of my Semester of Service experience." Karen Sarmir, East End Community Services; "Though it may seem cliché, I've learned that we're all the same. In the right circumstances we could all become poor or crack addicts or criminals. To blame the individual entirely is almost always a mistake. I've also learned more concrete lessons- like the injustice in the manner (by which) government handles poverty. Issues such as tax reform, budgeting, education, the environment, and many more have been shown to me first hand through Semester of Service. It is only when we become activists that we can confront these ills. I predict that this experience will be invaluable to my career, whatever it may be. I have developed interpersonal and intercultural communication skills that I may never have cultivated on the UD campus alone. Stepping off of the campus and into the city can truly be an intercultural event." Markus Zei, Salvation Army Booth House "Through Semester of Service I have learned about the prejudice that exists against young people living in poverty, especially regarding jobs. The subtle yet judgmental body language I have observed in public settings, directed towards people in poverty, is fascinating and infuriating. Everything I have been learning and seeing in my Semester of Service experience has reinforced my desire to be a teacher.
