- [VA Form 22-1990](#) (Application for Education Benefits/VONAPP) *if available for print*
 - Certificate of Eligibility
- _____ You may still have out-of-pocket expenses. You are required to pay the remaining portion of tuition and fees not covered by the VA by posted fee payment deadlines.
- _____ VA will pay tuition and fees directly to the University of Dayton. If you are eligible for the stipend and BAH, this will be paid directly to you.
- _____ You are required to sign up for certification each semester via the provided online form, in order to certify your enrollment each term.
- _____ You must submit copies of transcripts from previous institutions to verify transfer credits.
- _____ All courses you register for must be required for your program of study or elective requirements. You will be responsible for any tuition and fees for any course not applicable toward your degree program. If you are not sure whether a course will meet a degree or elective requirement, please ask your academic advisor before registering for the course.
- _____ You may retake a course if you failed the course with a grade of F. VA benefits will not cover a retake of a course with a grade of D or higher unless your degree requires a higher grade. The UD Veterans Services Office needs confirmation that you earned the F from your instructor.
- _____ You are required to notify this office and complete [VA Form 22-1995](#) if you change your program of study. Your certification status will be considered inaccurate until completed.
- _____ You are required to notify this office any time you add or drop courses. Failure to do so will result in incorrect payment and/or a debt to the VA.

- _____ Withdrawing from courses after tuition and fees have been paid is considered an overpayment by VA. Overpayments will be charged to you through Debt Notification by VA. If you do not attend courses, but fail to officially withdraw, you will be responsible for reimbursing tuition and fees to the University of Dayton.
- _____ If you receive a punitive grade without mitigating circumstances, your education benefits can be terminated/reduced effective the first day of class. The Office of Student Accounts will be required to refund all tuition and fee payments to the VA. This action will create an outstanding debt to the University of Dayton. You are responsible for re-paying tuition and fees to the university. Failure to do so will result in a hold on your account that may stop future registration, and your account may be referred to collections. All costs, expenses, late fees, and attorney fees related to the collection of your debt will be charged to you.
