Qualified applicants may receive up to the following award amounts (with a matching amount from the VA), once per academic year:

- **Undergraduate students:** Awards up to ½ of remaining unfunded tuition
- **Graduate students:** Awards up to ½ of remaining unfunded tuition
- **School of Law students:** Awards up to ½ of remaining unfunded tuition for 20 students

- ___ I understand that the Department of Veterans Affairs establishes eligibility for the Post 9/11 benefit and the participation in the Yellow Ribbon Program is contingent on VA approval.
- ___ I believe I am 100% eligible for the Post 9/11 benefit based on the following criteria set and determined by VA:
 - I served at least 36 months on active duty (either all at once or with breaks in service), or
 - I received a Purple Heart on or after September 11, 2001, and was honorably discharged after any amount of service, or
 - I received a Fry Scholarship on or after August 1, 2018, or
 - I served for at least 30 continuous days (all at once, without a break) on or after September 11, 2001, and was discharged after 60 days with a service-connected disability, or
 - I am a dependent child using benefits transferred by a Veteran or a service member who has served for at least 36 months on active duty and qualifies at the 100% level, or
 - I am a dependent spouse using benefits transferred by a Veteran, at the 100% level, and service member is no longer on Active Duty.
- ___ I understand that if I do not provide the Veterans Service Office at UD with all proper documentation and follow policies and procedures, I will not be considered for the Yellow Ribbon Program.
- ___ I understand that UD only awards Yellow Ribbon in one semester per academic year. This is awarded only during the semester that I reach the VA annual tuition benefit cap.
- ___ I understand that University of Dayton is not required to continue making Yellow Ribbon Program contributions if I am not in good academic standing or if UD does not renew the Yellow Ribbon agreement with the VA for the following academic year.
- ___ I understand that if I have any outstanding VA overpayments with previously attended institutions of higher learning that I may be ineligible to receive Yellow Ribbon funding.
- ___ I understand that upon confirmation of Yellow Ribbon eligibility, institutional need-based awards from the university may be adjusted.
- ___ The information submitted on this request is true and correct to the best of my knowledge.
