Use this form to obtain an I-20 to bring your **spouse and/or dependent children** to the US. ISSS will issue an I-20 which the dependent will use to obtain an F-2 visa. Please be aware that dependents:

- may remain lawfully in the U.S. only as long as the F-1 student is maintaining status.
- may not accept employment in the U.S.
- may not engage in full time study.
- may engage in study that is avocational or recreational in nature.

If your dependent is a child, please also be aware that s/he:

- may only engage in full time study if the study is in an elementary or secondary school (kindergarten through twelfth grade).
- must be unmarried and under 21 years of age.

You must demonstrate the ability to support your dependents by providing proof of funding **in addition** to the funds used to cover your **annual** tuition, fees, and living expenses. This amount must be shown regardless of the length of time your dependent(s) will stay in the US. Refer to the table below to find your financial burden then add the dependent financial burden.
