

## CALLINGS

### Program Rules and Agreement

The University of Dayton is a residential academic community. The residential character of campus life at UD provides students with the opportunity to develop intellectually and socially, to examine their commitment to religious faith, to clarify and strengthen their moral beliefs and their personal values and to experience the bond of community. We expect that participants in the Callings program will be enthusiastic and responsible. We do not expect to experience discipline problems, but if we do, a Callings staff member will handle them immediately.

By registering for the CALLINGS program, you and your parents/guardians agree to support these program rules:

1. Participants must stay on the University campus at all times during the session. Transportation is provided to all program functions away from the main campus. Participants are NOT allowed to leave the residence hall at night.
2. Participants will tour neighborhoods and partner social service agencies and participate in an off-campus service and community engagement. Community members view Callings participants as representatives of the University. All participants are expected to dress and behave appropriately.
3. Participants will not be permitted to have guests on campus during the program.
4. Buildings at University of Dayton are smoke-free. Smoking is permitted in designated smoking areas.
5. The use of intoxicants, including drugs and alcohol, is prohibited.
6. Cooking in the residence halls is prohibited.
7. There is a mandatory **12:00 midnight curfew every night** which is enforced by a night check made by the Callings staff. Please be respectful of others' need for sleep.
8. Attendance will be taken at all activities. Participants must attend and be on time for all activities.
9. Participants must keep Student Leaders informed of their whereabouts at all times.
10. Contact Callings staff in case of illness or if you are experiencing any symptoms.
11. At this time, Montgomery County has a low community level of COVID-19. Current University Protocols are located here:

12. In case of an emergency while participant is in attendance at Callings, parents may contact Callings staff by calling the Campus Ministry Office at 937-229-3339, from 8:30 a.m. to 4:30 p.m. weekdays or 937-409-6503 after hours.
13. Nametags must be worn in a visible place at ALL times (Nametags also function as meal tickets).
14. Photos taken and written comments made during the week may be used for program publications.
15. In the event of a fire alarm, you must evacuate the building. Lock your door and take your key. Do not use elevators.
16. It is a federal offense to pull a fire alarm under false pretenses. Anyone caught pulling a fire alarm intentionally will be dismissed from the program immediately. Legal action will be taken.

17. Failure to adhere to any of these rules is cause for dismissal with no refund of fees.
18. Upon dismissal from the program, parents must make arrangements for transportation home immediately.
19. Program ends at 12:00 noon. All participants must be checked-out of the residence hall by this time. If needed, transportation to/from airport or bus station may be arranged with the Campus Ministry office (at least 2 weeks in advance).
20. Participants are responsible for their residence hall room keys. Lost key charge is \$100; lost key card is \$10.
